For the period January- June 2024, our contribution revenue totals \$1,985.08 and our new membership dues total \$700.00 for a grand total of \$2,685.08. This is a increase of \$710.08 from last year. In addition, we received an additional \$2,984.88 from Giving Challenge donations. Expenses for this period were \$355.75 compared to \$3,707.82 for January-June 2023, a decrease of \$3,352.07. We have a year-to-date surplus of \$5,314.21. ## FCA Tampa Bay merger with FCA Sarasota-Manatee

While our merger is complete, we have more work to do. We updated our profile at the Giving Challenge and participated in this year's Giving Challenge. We initiated our survey of the 4 northern counties - 115 providers. Fortunately, we inherited a contract with a family-owned funeral home, Brewer and Sons with 7 chapels and the rates are as good as or better than our preferred providers. We will merge the two chapter rosters soon. We are just working out the format details to keep some original identity as we have duplicate member numbers across the both rosters. Your member number won't change.

### **GIVING CHALLENGE 2024**

Giving Challenge 2024 was a great success for our chapter. After a few fees that were unavoidable, we raised \$1160 from online donations and \$400 from foundation donor advised funds. We received a Patterson Foundation match of \$1425 for a total of \$2984.88. That total will help us bolster our reserves to continue providing you the best service and advice in making your final arrangements. A special thanks to all who contributed.



# **HEARTWOOD PRESERVE**

Our Vice President, Rich Gilbert, discovered this hidden gem in Trinity, FL near New Port Richey. Heartwood Preserve is a conservation cemetery offering Natural Burial which takes the environmentally friendly practice of a simple, traditional burial and advances that concept to promote a greener world by keeping land in its natural state.

Heartwood is a nature preserve carved out of the Starkey Ranch, now known at Jay B. Starkey Wilderness Park. It has 1000 acres of longleaf pine and flatwoods (lots of palmettos) and wetlands with cypress. Heartwood does prescribed burns from time to time, but that has no effect on those interred there. The cemetery occupies a little over 40 acres in the preserve.

As a natural cemetery, they offer traditional burial without the use of vaults. For you, this means that, unlike a conventional cemetery, you will not have to purchase a vault or grave liner. You have the option of burial with or without a casket and with or without an urn. Casket selection can be made upon approval by the cemetery, the use of a shroud is also acceptable. All burial containers they accept should be sustainably-sourced and 100% biodegradable, in keeping with their conservation mission and goals. Most 'green burial' containers purchased from funeral providers are welcome, upon approval from Heartwood Preserve's management staff. The Green Burial Council has a good list of appropriate options, although theirs are not the only options that are acceptable. Many products, such as locally made ones, meet natural burial standards but have not become certified by the GBC. www.greenburialcouncil.org

Each burial includes the use of their beautiful Welcome Center for an hour prior to or just after the burial itself. It is available at a special Heartwood Family rate to rent for longer gatherings on the burial day. Some families enjoy having the convenience of staying for a potluck or a catered celebration of life party while at Heartwood rather than driving to someone's home or a restaurant.

So, what does this all cost. Full body interment is \$4250 and cremation burial interment is \$1650. About the only thing not included is a small stainless-steel marker designed to withstand those controlled burns. Keep in mind you still have the costs of a funeral home to pick up and transport the body. We are considering inviting Heartwood Preserve to our Annual Meeting in January for a presentation of this one-of-a-kind cemetery.
